- The deadline for entries is June 30, 2024.

- There are no geographical restrictions regarding entries. Organizations from any country can enter.
- Winners will be announced at a designated time and location during the conference.
- A project or event may be entered into more than one category.
- An organization may enter a maximum of one team and one individual entry only.
- Judges reserve the right, without prior consent of the entrant, to move entries to different categories if they feel it is more appropriate.
- The judges' decision is final, no correspondence will be entered into, and no reasons given for decisions.
- Judges will absent themselves from any discussions where they have a vested interest.
- All information provided to judges will be used solely for the purposes of assessing the entries. Potentially sensitive information will not be made public.
- Winners may state in advertising and promotional material that they have won.
- By submitting your entry, you certify that, to the best of your knowledge, the information provided is correct and adheres to the specific requirements of that category.

Nomination Essay

Entrants have a maximum of 1,000 words in which to convince the judges that the individual or team they are nominating is worthy of winning an award. Please include any information which will persuade the judges that this should be the winning entry for the designated category. Suggestions as to what could be covered are listed below:

- Give some background for the entry including how it originated and what it set out to achieve. Outline any specific goals or targets you had in mind prior to the event being put together and implemented.
- Describe the research that went into developing and implementing the entry. Give details of the research, processes, and techniques used.
- If relevant, please describe how you interacted with stakeholders and/or third parties, to develop creative approaches to meeting objectives.
- Describe the features and benefits of your entry, including application approaches.
- Describe any metrics which validate the success of your entry.
- Give any other information regarding the entry which you think would help convince the judges that your entry should win this award. What makes your entry so unique? In what ways have you been particularly innovative in developing your entry?

Shortlisted Summary

In the event your submission is selected, we will publish a 200 word summary of your submission in the conference brochure. Please attach a summary document keeping in mind that any results or other sensitive information may end up in the public domain.
